Booking / Charter Agreement - Terms & Conditions

- 1) **A deposit of 50% must be paid to confirm a charter/booking, with the balance due before the day of and prior to departure.** By prior agreement, recognized agencies, organizations and existing clients may be invoiced periodically depending on the nature and number of the charter periods.
- 2) Payment may be made by Cash, BACS, Cheque or Money Order made out to “North Irish Diver Ltd.” or Debit/Credit Card.
- 3) On confirmation of the Booking / Charter Agreement, North Irish Diver Ltd. will commit to provide the vessel “North Irish Diver”, crew and services as stated in the quotation/tariff for the duration of the charter period(s). At this point the client/hirer will have entered into an agreement to pay North Irish Diver Ltd. the full amount of the Booking / Charter(s), and North Irish Diver Ltd. will have lost the right to offer the hire of the vessel or services to other interested parties during the period of the charter(s).
- 4) Cancellation: If the hirer is compelled to cancel a booking please notify us immediately in writing and we will endeavour to rehire the vessel/services to another party. The original client/hirer will still be liable for the total amount of the agreement however if we are successful in rehiring the vessel/services, North Irish Diver Ltd. will deduct from the original agreement such monies as has been gleaned from the subsequent hirer. Any outstanding balance to the original agreement will remain the responsibility of the original client/hirer. **Customers are advised to source their own insurance to cover this eventuality.**
- 5) Cancellation due to adverse weather conditions: The vessel is certified to operate up to 20 miles from a safe haven in favourable weather conditions as defined by the MCA. In the event of North Irish Diver Ltd. not being able to operate the vessel or services due to adverse weather conditions, a full refund of any deposit/monies paid will be made to the client/hirer and the hirer will have no claim on any account against the company. It will be the decision of the Skipper on the day to determine if conditions are suitable and safe to operate. We will endeavour to be flexible with rescheduling.
- 6) The booking is made on the understanding that the vessel and crew will be made available to the hirer on the date and time as agreed in the booking, unless North Irish Diver Ltd. is prevented from doing so by circumstances not under our control. In this case a full refund of any monies paid will be made to the hirer and the hirer will have no claim on any account against the company.
- 7) In the interest of Health & Safety all passengers must pay attention to the Safety Briefing and adhere to all safety notices and instruction whilst on board the vessel. Unruly passengers or those under the influence of alcohol or drugs will not be permitted to travel onboard the vessel. The Skipper will have sole command and authority while the vessel is at sea and all passengers must adhere to his instructions. Any breach of this condition will result in the vessel putting into the nearest suitable port and the relevant authorities informed. There will be no refund in this case and the client or offending passenger(s) will be liable for any additional expense incurred by the company or other inconvenienced passengers.
- 8) **All invoiced accounts are due within 30 days from the date of the invoice.** North Irish Diver Ltd. reserves the right to charge interest on any overdue account at the rate of 10% per month & charge the current company administration fee (£30) for any referred cheque. Additional charges may be made should any overdue account receive the attention of a third party debt collection service.

We hope that you find these Terms and Conditions fair to both parties. We will always endeavour to provide you with a pleasant and memorable experience, and we will remain as flexible as possible regarding bookings and weather conditions. Please bear in mind that any cancellation can deprive us or another interested party an opportunity of booking the vessel.
